(Vacancy : General - 284, SC - 95, ST - 19, OBC - 44, Ex-Serviceman - 24, Total - 466)

Applications from the Indian male citizens only are invited in the prescribed format as given below for the aforesaid recruitment. Pay Scale (5400 - 25200 + GP 2600). The examination will be held in three successive stages, (a) written test (objective type), (b) endurance test and (c) interview. The written test will be held at different centres in Kolkata. The endurance test will be held for the qualified candidates to be selected on the basis of the written test and the interview will be held for the qualified candidates to be selected on the basis of the result in aggregate of the written test and endurance test.

<b>Essential Qualifications :</b>	Passed Madhyamik or equivalent examination from any recognized Board or University.
<b>Desirable :</b>	(i) A certificate from Industrial Training Institute in (a) Civil Engineering, (b) Electrical Engineering, (c) Mechanical Engineering, (d) Automobile Engineering, (e) Hydraulic Engineering, (ii) Swimming Certificate from recognized Club or Institute; (iii) Driving licence for light or medium vehicle.
<b>Physical Measurement :</b>	(i) Minimum Height : 5' 6"; for Gorkhas and other hill tribes - 5' 3", (ii) Chest : Minimum 32" and on full expansion 34".
<b>Age :</b>	Between 20-27 years on the 1 <sup>st</sup> day of January, 2010. The upper age limit is relaxable in case of SC/ST/OBC candidates as per Act/Rules/Government Order made in this behalf.
<b>Note :</b>	Provision of West Bengal Service (Raising of age limit) Rules, 1981 will not be applicable.
<b>Fee:</b>	Candidates must enclose with their application a fee, non-refundable, of Rs. 100/- (one hundred) only in the form of Bank Draft in favour of Director General, West Bengal Fire and Emergency Services, payable at Kolkata.
